C. CIPP Equipment & Materials

Commissioners Rahl and Smith moved to spend \$36,000 in ARPA funds to use towards the CIPP equipment and materials. Roll Call Vote: Yeas, Charbonneau, Smith, Webb, Gwizdala, Rahl, Putt, Mayor Kilbourn. Nays, none. Motion Carried.
