A. ARPA Funds

Commissioners Gwizdala and Charbonneau moved to spend \$25,000 of ARPA Funds for fencing at the Lagoon. Roll Call Vote: Yeas, Commissioner Rahl, Commissioner Webb, Commissioner Putt, Commissioner Charbonneau, Commissioner Gwizdala, Mayor Kilbourn. Nays, none. Motion Carried. City Administrator David Haag stated ARPA funds could be used to chip and seal some roads or it could be invested in new pumps at the lift station.

B. Salt Spreader

C. DPW Position

Discussion was made amongst Commissioners for what the DPW position will entail.
